1. PRIVACY POLICY

Ethos Building & Restoration is committed to protecting the privacy of an individual's information. We value the privacy of our customers, clients, employees, contractors, and third-party affiliates and take every precaution to safeguard your personal information. This policy outlines our ongoing obligations in respect of how we manage your Personal Information. We have adopted the Australian Privacy Principles (APPs) contained in the Privacy Act 1988 (Cth) (the Privacy Act).

The APPs govern the way in which we collect, use, disclose, store, secure and dispose of your Personal Information. A copy of the Australian Privacy Principles may be obtained from the website of The Office of the Australian Information Commissioner at www.aoic.gov.au

2. PERSONAL INFORMATION

Personal information is information or an opinion about an individual, or an individual who is reasonably identifiable, whether the information or opinion is true or not, or is recorded in a material form or not.

Personal information that Ethos Building & Restoration may hold includes but is not limited to:

- your name, address, telephone number, fax numbers, email address, driver's licence details, information about use of our services, insurance history, employment details and history and information about properties previously or currently owned or rented.
- records of our interactions with you, such as telephone conversations and system notes
- historical information such as prior insurance claims and services provided by Ethos Building & Restoration

This Personal Information is obtained in many ways including correspondence, by telephone, by email, and or via our website www.ethosbuilding.com.au. We may also collect personal information via and including:

- when liaising with your insurer and other third parties such as loss adjusters and brokers
- Trade & Supplier application forms.
- when we conduct credit checks through credit reporting bodies or various public domain databases
- When you pay for goods or services with methods other than cash
- When we make enquires through ASIC, Centrelink, or the Titles Office
- When evaluating job applicants and personnel, including their contact details, employment history, educational qualifications, and reference checks. This may include "sensitive information".

We collect your Personal Information for the primary purpose of providing our services to you, providing information to our clients and for marketing purposes. We may also use your Personal Information for secondary purposes closely related to the primary purpose, in circumstances where you would reasonably expect such use or disclosure. You may unsubscribe from our mailing/marketing lists at any time by contacting us in writing.

When we collect Personal Information, we will, where appropriate and where possible, explain to you why we are collecting the information and how we plan to use it.

3. SENSITIVE INFORMATION

Sensitive information is defined in the Privacy Act to include information or opinion about such things as an individual's racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

Sensitive information will be used by us only:

- 1. For the primary purpose for which it was obtained
- 2. For a secondary purpose that is directly related to the primary purpose
- 3. With your consent, or where required or authorised by law.

4. THIRD PARTIES

Where reasonable and practicable to do so, we will collect your Personal Information only from you. However, in some circumstances we may be provided with information by third parties. In such a case we will take reasonable steps to ensure that you are made aware of the information provided to us by the third party.

5. DISCLOSURE OF PERSONAL INFORMATION

Your Personal Information may be disclosed in a number of circumstances including the following:

- To third party goods or services providers for the purpose of delivering our business services
- Your insurer, loss adjuster, managing agent and or landlord for the purpose of delivering our business services.
- Where required or authorised by law.

However, most of the Personal Information is or will be stored in client files which will be kept by us for a minimum of 7 years.

You may access the Personal Information we hold about you and to update and/or correct it, subject to certain exceptions. If you wish to access your Personal Information, please contact us in writing.
